6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

Judiciary has an existing contract with National Council of Juvenile and Family Court Judges(NCJFCJ) which was negotiated to conduct a statewide assessment which include three phases(i.e. Baseline Assessment, Recommendation Implementation, and Improvement Assessment). NCJFCJ is aware of the Hawaii State Judiciary process as they have completed statewide site visits and reports. NCJFCJ is well aware of the CIP expectations. NCJFCJ have collaborated with the Department of Human Services, Family Court Statewide and other Child Welfare service providers.
