**Section 1.4 Item 2 - Court Security Officer** – All references in this section and in this IFB to the position entitled “Court Security Officer” shall be changed to read “Security Officer I”.
- C. Modifications to SECTION THREE – OFFER FORM**  
**TABLE A AND TABLE B OF THE OFFER FORM –**
- 1) Location 9b of both tables shall be clarified as “Kapolei Court Complex – Security Officer I”
  - 2) Location 29b of both tables shall be clarified as “CC5 Puuhonua Kaulike – Lihue – Security Officer I”
  - 3) The far right column header of TABLE B only entitled “07/01/15 – 06/30/16” is incorrect and shall be corrected to read “07/01/16 – 06/30/17”.
- D. Modifications to ATTACHMENT 1 – Judiciary Facilities & Offices. (The following corrections are in line with the corrections in this Addendum No. 1, Item C above.)**
- 1) Location 9b shall be clarified as “Security Officer I” positions.
  - 2) The 4 positions at Location 29 shall be clarified as “3 Security Attendants” and “1 Security Officer I” positions.
