UNCONTESTED CIVIL UNION DIVORCE W/CHILDREN FILING INSTRUCTIONS

- **<u>Step 1</u>** Fill out the following documents. You can type or print legibly with black ink:
 - 1). <u>Kids First Information Sheets</u> (Orig + 1)*both pink (*If you and your spouse have minor children together*)
 - 2). <u>Complaint for Civil Union Divorce, Automatic Restraining Order and</u> <u>Summons to Answer Complaint for Civil Union Divorce</u> (Orig + 2)
 - 3). <u>Civil Union Divorce Action (CUDA) Information</u> (Orig + 1)
 - 4). Income and Expense Statement (Orig + 1)
 - 5). <u>Asset and Debt Statement</u> (Orig + 1)
- <u>Step 2</u> File the documents in Room 106 of the Courthouse located at 2145 Main Street, Wailuku, Maui, Hawai`i
- **<u>Step 3</u>** Serve your spouse the following documents:
 - 1). <u>Complaint for Civil Union Divorce</u>, <u>Automatic Restraining Order and</u> <u>Summons to Answer Complaint for Civil Union Divorce</u>

There are **3** ways to serve your spouse:

- Your spouse can sign the document titled <u>Appearance and Waiver</u> in front of a Notary Public if your spouse agrees with the divorce, the division of assets and debts (and the arrangements for custody, visitation and child support if you have minor children together).
 - A). Your spouse must fill out an <u>Income and Expense Statement</u>, an <u>Asset and Debt Statement</u>, the appropriate <u>Child Support Guidelines</u> <u>Worksheet</u> (signed by you and your spouse *if you have minor children*), and the <u>Civil Union Divorce Decree with Children with Proposed Cover Sheet</u> (signed by you and your spouse), if your spouse signs the <u>Appearance and Waiver</u>. File the documents in **Room 106** at the Courthouse.
- 2). A reliable friend or relative, who is at least 18 years old, can hand deliver the documents to your spouse. The person who delivers the documents must then fill out the document titled <u>Proof of Service</u> and return it to you for filing with the Court. File Proof of Service after service is made.
- 3). Hire a Process Server to serve your spouse with the documents.

- <u>Step 4</u> Fill out the following documents *after* (1) your spouse has signed the <u>Appearance and Waiver</u> (see <u>Step 3</u>), *or* (2) **20 days** have passed since your spouse was served with the documents and no answer was filed by your spouse. You can type or print legibly with black ink:
 - 1). <u>Child Support Guidelines</u> (*if you and your spouse have minor children together*)
 - 2). Affidavit of Plaintiff
 - 3). Request for a Non-Hearing Uncontested Divorce
 - 4). <u>Civil Union Divorce Decree With Children with Proposed Cover Sheet</u> (*if you and your spouse have minor children together*)
 - 5). Order/Notice to Withhold Income for Child Support with Proposed Cover Sheet (if you and your spouse have minor children together)
- <u>Step 5</u> File the documents in Room 106 at the Courthouse. It takes approximately 2 weeks for the judge to review and sign your documents.

To obtain copies of your Divorce Decree, you may purchase copies online at <u>www.courts.state.hi.us</u> on eCourtKokua or you may purchase copies at the Legal Documents Branch in Room 106 of the Courthouse located at 2145 Main Street, Wailuku, Maui, Hawai`i.

- 2. Obligor (person paying child support)
- 3. Obligor's Employer
