Subsequent to installation of this system at the CJC's statewide, major problems have occurred with no permanent resolution. This includes problems recording child abuse victim interviews and making copies of the DVD interviews. The problems have major negative impact on cases, adding more trauma to victims and compromising access to justice for parties.
