6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

Mr. Heimgartner has been a licensed and practicing attorney in the State of Hawaii since 2008. As a Deputy Public Defender for the State of Hawaii, he received training and obtained valuable experience with juveniles in the Judiciary system. Now in private practice and recently contracted with the Third Circuit as a GAL/LC, he would like to continue his commitment. Efforts to recruit attorneys through the Request for Proposal process under J16003 in 2015, did not produce enough attorneys to absorb the amount of referrals from the Family Court of the Third Circuit.

Due to the shortage of GAL/LC providers in West Hawaii, it is critical for the Judiciary to continue to contract with Mr. Heimgartner.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

Mr. Heimgartner has expressed an interest in continuing to be a Guardian Ad Litem for the Third Circuit . Due to lack of adequate response to the 2015 RFP J16003 and possible retirements of other contracted attorneys, it was decided by administration and the current presiding Family Court judges, that the need for another contracted GAL was immediate.
