*Pursuant to HRS § 103D -102 (b)(4) and HAR Chapter 3-120, The Judiciary requests a procurement exemption for the following:*

<p>1. Describe the goods, services or construction: (This Form CP-3 for RQ#C4131 replaces previously approved RQ#C3837.)</p> <p>JUD Contract J11134 To Provide Installation And Recurring Costs For Wide Area Network (WAN) Connectivity To The Judiciary, State Of Hawaii, is currently on it's last 12 month extension from July 1, 2014 to June 30, 2015. We are requesting an exemption to extend this contract for another 12 month period from July 1, 2015 to June 30, 2016. If this exemption to extend our current WAN is approved and the 2015 State Legislature approves our New WAN (having greater band width), the extended time period (from July 1, 2015 to June 30, 2016) will allow us time to develop the IFB for the New WAN system. The approximate time to implement a NEW WAN state-wide is 8 months.</p>	
<p>2. Vendor/Contractor/Service Provider:</p> <p>tw telecom</p>	<p>3. Amount of Request:</p> <p>\$150, 600 per year; Computer Special Funded at this time. (12 months X \$12,550 per month. This is our current cost for J11134.)</p>
<p>4. Term of Contract From: To:</p> <p>Extend contract J11134 from July 1, 2015 to June 30, 2016.</p>	<p>5. Prior Judiciary Procurement Exemption No. (if applicable):</p>
<p>6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:</p> <p>If we were to submit an IFB at this time for a 1 year duration for the same/existing WAN configuration, and tw telecom is not the awarded vendor, there would be an 8 month implementation time for the new vendor to buildout the same WAN configuration, then disconnect and reconnect all of our 33 sites. Additionally, if there is a change of vendor, their bid may be higher than our current tw telecom rate. If this exemption request is approved to extend the current tw telecom WAN Contract J11134, there would be no implementation time required for disconnecting and reconnecting all of our 33 sites.</p>	
<p>7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:</p> <p>We would be extending the existing contract J11134 with tw telecom for 1 additional year at the same cost.</p>
