Pursuant to Section 3-120-5 of the Hawaii Administrative Rules, the Fifth Judicial Circuit request a procurement exemption to renew a one year safeguard maintenance agreement from Jefferson Audio Video Systems, Inc. (JAVS). The past agreement, Contract #J07045, expired on August 31, 2012, but due to non-compliance of JAVS with Hawaii Compliance Express (HCE), renewal of the contract has been delayed. JAVS is currently compliant with HCE. This agreement will cover the Court Documentation Systems, utilized in our courtrooms & conference rooms and is considered proprietary due to key software and hardware components and configurations. JAVS is the sole provider of the maintenance to this system. The cost is \$35,794.00 plus applicable tax for a one year agreement from 9/01/12 to 8/31/13, and applicable to courtrooms 1-6, three conference rooms, the Multi Purpose room and router and the Security Audio Video Intercom System. JAVS will perform a tri-annual inspection, cleaning and adjustment of the system; equipment failures will be addressed and repaired promptly. As procurement of these services by competitive means is neither practical nor advantageous to the Judiciary, we submit this exemption request and certify to the best of our knowledge that the information provided is true & correct.
