Re: SECOND REQUEST FOR EXEMPTION TO
CONTINUE SERVICES WITH MUNICIPAL
SERVICES BUREAU (MSB),
5th Amendment to Agreement.

It is respectfully requested that an exemption for collection services through MSB be provided under the terms of the existing Agreement J05105, until the new Agreement J13080 (solicited and awarded in response to RFP J13080), has been fully executed. The current contract J05105 with MSB, as amended, will expire on December 31, 2012.

The exemption shall be for the period of January 1, 2013 through the close of business on January 31, 2013. The new contract J13080 term would be February 1, 2013 through January 31, 2018 with extensions or two additional 12 month periods.

At this time, the exemption is being requested due to delays in MSB obtaining HCE compliance. While MSB had initiated the HCE paperwork prior to Award, given the holiday season, it has taken an unanticipated amount of time to obtain approvals. Currently, MSB is compliant with the State Department of Taxation, the State Department of Commerce and Consumer Affairs and the Internal Revenue
