Family Programs Hawaii (FPH) is a unique service that teach, demonstrate, and coach parents of how to best care for their infants and toddlers. Unlike other parenting programs that are educational, cultural, or teach hands-on parenting skills, FPH models appropriate parenting behaviors and methods for attunement. FPH teaches protective factors to parents to reduce risk factors for families. The families are given opportunities to practice these skills at FPH's visitation located in Maili. FPH's visitation center will cater to Child Welfare Service (CWS) families that are from west Oahu. The location of the visitation center makes the service easily accessible for a high percentage of CWS cases in this area. Elements of Theraplay and Circle of Security are coaching models that FPH uses and there are no other programs that offer these services in west Oahu. It is not practicable and not advantageous for Hawaii Zero to Three/Family Drug Court to procure the service by competitive means since no other program coaches parents using the strategies from the models above, counsels the caregivers, counsels the biological parents to lower anxiety levels about parenting, ensures attachment between biological parents and infants/toddlers upon their family reunification, and has a visitation center on west Oahu. Four FPM trained parenting coaches will be dedicated to the families of the Hawaii Zero to Three/Family Drug Court. FPM will offer services seven days a week and at all hours for the referred families, to meet the rigorous schedules of all the parties involved.
