Provide Consulting Certified Arborist Services for two trees on Honolulu's Exceptional Trees list (a Kauri Tree and a Tamarind Tree, both located on the Ewa side of Ali'iolani Hale). Services include supervision of pruning, monitoring, providing additional treatments (such as fungicide application) as required to restore and support the health of the trees and secure the safety of passersby and protect nearby real and personal properties from damage.

6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

The Kauri and Tamarind trees are stressed in different ways and require expedited attention as follows:

Kauri Tree: At request of Judiciary, Mr. Nimz performed a field inspection of the Kauri Tree. According to his November 30, 2015 report, the Kauri tree is showing significant signs of decline and senescing in the upper crown. Mr. Nimz recommends immediate removal of dead branches before branch failure occurs. Branch failure in neighborhood trees has recently caused significant injuries to persons and the condition of this tree poses similar risk of serious injury or death to persons and/or damage to property. Mr. Nimz has assisted our preparation of the paperwork required to apply, through the Honolulu Arborist Advisory Committee and City Arborist to the Director of Parks and Recreation, for a permit to prune the Exceptional Kauri tree.

Tamarind Tree: This tree has a hollow that is currently occupied by a massive beehive. The condition of the hollow is suspect and must be inspected once the beehive is relocated. The tree also has many shoots and is in need of pruning. In coordination with his work on the Kauri Tree, Mr. Nimz woul assess and prescribe treatment for the Tamarind tree, would possibly perform that treatment and would oversee the pruning to restore its health. Mr. Nimz will assist in preparation of our application for a permit to prune the Exceptional Tamarind Tree.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

Due to extensive involvement with pruning work on both trees, Mr. Nimz is in a unique position to perform consulting services on an expedited basis.

DAGS Public Works recently managed an Exterior Alterations and Improvements project at Ali'iolani Hale for The Judiciary. That project involved repair, relocation and creation of new sidewalks on the Ewa side of the building along Mililani between the Kauri tree and the building and in the Ewa courtyard around the Tamarind tree. The sidewalk improvements required root pruning of both trees. All pruning of Exceptional Trees must be done under the direct supervision of a certified arborist. As a subconsultant to Mason Architects, the prime consultant on the project, Mr. Nimz was the consulting certified arborist supervising the root pruning of both trees.
