KIDS FIRST INSTRUCTIONS

KIDS FIRST is a program designed to help parents understand the effects of separation and divorce on their children and to help children cope with changes in their families. BOTH parents <u>must attend</u>. Children (age 6-17) of either Plaintiff/Petitioner or Defendant/Respondent, from this and any other relationship who have lived with Plaintiff/Petitioner and Defendant/Respondent's current family, <u>must attend</u> Kids First unless excused by the Judge.

Failure to attend may cause you to be brought before the Court to explain your non-attendance and may be considered a factor in custody decisions. Non-attendance may also delay the granting of your Paternity Judgment or Divorce Decree.

PARENTS' AND KIDS' CLASSES

The Parents' and Kids classes are held in person, alternating between the Kapolei Courthouse and Alder St Complex. The time of the class is from 4:30 pm-6:30 pm at the Kapolei Courthouse and 5:00 pm-7:00 pm at the Alder St. location. Please check your **Kids First Notice** for location.

You and your children will watch a video in your classrooms. Parents will have their own program presented by psychologists specializing in paternity and divorce. The children and teens will be grouped by age and led by trained facilitators. They will play games, see the courtroom, role play, and may express their feelings about the paternity case or divorce.

NO CHILDREN UNDER THE AGE OF 6 OR any child not listed on page one. Babies and minor children Children are not allowed in the parents' program. If you bring a child under the age of 6, you must reschedule for another day.

Please keep in mind that this is a one-time class.


