
ORDER ADOPTING FINANCIAL DISCLOSURE STATEMENTS FORM

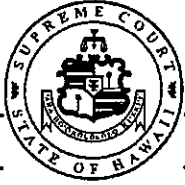
