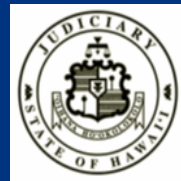

Since 2005, the third Thursday in October has been celebrated as Conflict Resolution Day.<sup>1</sup> On this day alternative dispute resolution organizations, universities, schools, etc., join together to recognize the importance of conflict resolution.<sup>2</sup> Conflict is something that all of us must face during our lives. Conflict resolution comes in many forms such as traditional methods like negotiation or decisions of a court, i.e. liable or not liable, guilty or not guilty, or through various forms of alternative dispute resolution (“ADR”) such as mediation, arbitration, conciliation, etc. Although each form of dispute resolution has a particular aspect which lends it to being the appropriate method for each

dispute, it is mediation, arbitration, conciliation, and such, which Conflict Resolution Day is intended to highlight.<sup>3</sup> Through mediation, conciliation, and facilitation, parties in a dispute are provided the opportunity to craft resolutions that best meet their needs, repair relationships, and develop ways of communicating to avoid future conflict. Since 1989, the Center for Alternative Dispute Resolution (“Center”) has been an integral part of the efforts to provide ADR education, research, outreach and services, to the people of Hawaii. Much of the Center’s work, however, is only possible through the incredible graciousness of our many volunteers.

### THE APPELLATE MEDIATION PROGRAM

The Program provides appellate court-users the opportunity to mediate their case before continuing litigation in the courts of appeals. The Program utilizes the services of trained volunteer mediators who give their time and expertise to support the Program. There are currently 49 volunteer mediators who are retired justices or judges and retired or semi-retired attorneys appointed by the Chief Justice of the Hawaii Supreme Court. Using their expertise they have resolved over 50% of the approximately 600 cases that have gone through the Program since its inception in 1995. Their commitment to our community and the Judiciary is significant, and they are the core of the Program.
