Upon consideration of the Stipulation to Dismiss Appeal Pursuant to Settlement, filed August 24, 2015, by Defendant-Appellant Goodsill Anderson Quinn & Stifel, LLLP (Appellant), the papers in support, and the record, it appears that (1) the stipulation is dated and signed by counsel for all parties appearing in the appeal; (2) the parties seek to dismiss the appeal without prejudice, pursuant to Hawai'i Rules of Appellate Procedure Rule 42(b); (3) the appeal was docketed May 12, 2015; and (4) the parties agree to bear their own costs and attorneys' fees, and any outstanding costs owed the court will be paid by the party incurring the costs.
