- [] 1. Both parties shall appear at the Family Court of the First Circuit, Kapolei Court Complex, 4675 Kapolei Parkway, Third Floor, Kapolei, Hawai'i for a hearing on Movant's motion filed _____ ("Movant's motion") on _____ at _____.
- [] 2. This Amended Order for Hearing on Motion, together with Movant's motion and all attachments thereto, must be served on the Respondent by no later than noon on the Friday of the first week following the week in which this Amended Order for Hearing on Motion is filed. If service is made other than by personal service, service on the Respondent shall be made no later than twenty (20) calendar days (including weekends and holidays) prior to the hearing. If service is not timely made the Movant shall appear before the Family Court on the date and time set forth above and state the reasons why. A new hearing date shall then be set by the Family Court.
- [] 3. Any written response to be presented by the Respondent in response to Movant's motion must be filed and served on the Movant by no later than noon on the Friday prior to the hearing.
- [] 4. By no later than noon on the Friday prior to the hearing the Respondent shall (a) provide the Movant with a copy of his or her two (2) most recent pay statements, last W-2 statement, and last federal individual income tax return, and (b) file with the Court and provide to the Movant current Income and Expense and Asset and Debt Statements.
- [] 5. All prior orders herein shall remain in full force and effect.
