- (b) Upon a hearing, the child(ren) be decreed to be the legal child(ren) of the Petitioner(s), effective of as of the date of filing of this petition.
- (c) The name(s) of the child(ren) be decreed as set forth in paragraph numbered 4 above.
- (d) The Court decree such further relief as will serve the best interest of the child(ren).
