Offerer must understand the importance of sensitive nature if the information handling and all employees signed Confidentiality and Non-Disclosure Agreements and maintain strict internal policies pertaining to safeguarding and handling of client's information. Due to security concerns, physical printing facility must be located on the island of Oahu so it can be monitored periodically by the Officer-in-Charge to verify compliance.
