IGNITION INTERLOCK INSTRUCTION PERMIT APPLICATION

Instructions: Submit this application to the ADLRO along with 1) a copy of your Smart Start Ignition Interlock Lease Agreement as proof of installation of an ignition interlock device; and 2) proof of motor vehicle insurance or self-insurance for any vehicle in which an ignition interlock has been installed.

I, the undersigned Respondent, understand that the ADLRO will not issue me an ignition interlock instruction permit if:

1. My license is expired, suspended, or revoked as a result of action other than the instant revocation;
2. I have not petitioned the court and have not been granted an order allowing me to apply for the ignition interlock instruction permit;
3. I am under the age of eighteen.

I also understand that:

1. My Smart Start Ignition Interlock Lease Agreement is subject to verification by the ADLRO;
2. I must present proof of motor vehicle insurance or self-insurance that complies with the requirements of HRS §431:10C-104 or HRS §431:10C-105 for any vehicle in which an ignition interlock has been installed;
3. I must present proof of a valid motor vehicle registration.
4. I must present proof of having passed the written portion of the driver's license examination;
5. If granted, the ignition interlock instruction permit will allow me to drive only a vehicle equipped with an ignition interlock device in the State of Hawaii;
6. As a holder of an ignition interlock instruction permit, I must be accompanied by a person who is twenty-one years of age or older who is licensed to drive a category 3 vehicle and who shall occupy a passenger seat beside me while the category 3 vehicle equipped with an ignition interlock device is being operated.
7. **I will not be issued an ignition interlock instruction permit to operate a vehicle equipped with an ignition interlock device if that vehicle's motor vehicle registration is revoked, except as provided by law;** and
8. My ignition interlock instruction permit will expire within one year from the date that the examiner of drivers has determined that I am qualified for a permit.
