ORDER OF AMENDMENT

The Opinion of the court, filed on September 22, 2016,  
is hereby amended as follows:

1. On page 2, in the fifth line, the word "the"  
should be replaced with "that" so that as corrected, the text  
reads: ". . . arguing that Sarae . . . ."
2. On page 8, in the fifteenth line, the "\$" symbol  
should be inserted between "HRS" and "291C-26".
3. On page 10, in the fifth line, the word "would"
