QUESTIONS AND ANSWERS

1. Whether companies from Outside USA can apply for this? (like,from India or Canada)

Yes, they can apply, as long as they meet the requirements stated in 2.4.C.

2. Whether we need to come over there for meetings?

Section 2.4.C. states, "Offeror must be available during normal working hours and from where he/she will be accessible to requests or complaints. Offeror shall meet with the Judiciary and be available, accountable, and be responsible for qualification, processing, and scanning of returned Juror Questionnaires for the entire duration of the job."

3. Can we perform the tasks (related to RFP) outside USA? (like, from India or Canada)

No. This does not meet the requirements stated in Section 2.4.C.

4. Can we submit the proposals via email?
