Pursuant to HRS § 103F -101 (a)(4) and HAR Chapter 3-141, The Judiciary requests a procurement exemption for the following:

<p>1. Title and description of health and human service(s):</p> <p>Title: Agreement for Health and Human Services Transaction Exempt from Chapter 103F, HRS</p> <p>Description: This is a contract for mediation and related dispute resolution services.</p>

<p>6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:</p> <p>The Hawaii State Judiciary has a contract, J16053, as amended, with the Mediation Centers of Hawaii, Inc. (MCH) for the provision of mediation and related dispute resolution services for FY2016 - FY2019. For FY2020-FY2023, the Judiciary initially posted RFP J19100, SVC Spec 2.23, for the same services, and MCH was the sole applicant. The Judiciary is canceling the solicitation for SVC Spec 2.23 pursuant to Hawaii Administrative Rules Section 3-143-613 because we no longer need a two-year initial contract with a two-year extension. Although our requirements have changed, we still need the same services for a one-year period and are proceeding with a one-year exempt contract with MCH, as MCH was the sole applicant for these services. A one-year exempt contract would be more advantageous, because the shorter period allows greater flexibility in adapting to upcoming technological innovations. Specifically, in the near future, the Judiciary will be seeking online dispute resolution services. In the meantime, it is important that existing mediation and related dispute resolution services be maintained to ensure positive outcomes (e.g., case resolution, participant satisfaction, courthouse mediations, smooth court operations, mediator training, outreach and education, etc.) at current levels.</p>	
<p>7. Describe the reason for the selection of the provider including a description of how the procedure, as much as practicable, ensured maximum fair and open competition:</p> <p>MCH's current contract with the Judiciary J16053 ends on June 30, 2019, and the Judiciary needs the same services for a one-year period. MCH is well positioned to ensure the continuity of the same services. MCH is a well established organization of community mediation centers and programs located on Oahu, Maui, the Island of Hawaii, and Kauai. MCH has a track record of successful performance under prior mediation and related dispute resolution services contracts since 1991. MCH continues to work closely with the courts and CADR. MCH is familiar with the various courts, court procedures, and the Judiciary contract and billing processes. Continuing with MCH minimizes training a new contractor with the court system, the contract/billing processes, and CADR program expectations.</p>
