FTR installations in Hilo are at the end of their support lives. Addressing one issue initiates a cascade of compatibility complications. There is material probability that maintaining FTR functionality will require replacing entire systems. The Third Circuit owns FTR in Hilo courtrooms and JAVS in West Hawaii courtrooms. Due to our experiences with both systems, we believe a JAVS system will be more reliable, and less costly to maintain. These are important considerations for courts of record, and for stewardship of public resources.
