It is not practicable or not advantageous for the Program/Division to procure by competitive means because L-3 Communications Security & Detection Systems, Inc. is the proprietary provider of this brand of x-ray units. Due to the technical nature of the equipment and our reliance on this equipment to provide our courts with a safe and secure environment, it is essential that we retain L-3 Communications' services to ensure proper equipment performance up to manufacturer specifications. In addition to receiving prioritized response to service calls, preventive maintenance will be performed on the x-ray units.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:  
L-3 is the manufacturer of this equipment and is the only company in Hawaii able to provide certified maintenance services for this equipment located at Hoapili Hale.
