If Judiciary were to go out and bid for another vendor to install a software comparable to what is already in the system would mean that additional cost besides annual service maintenance cost would drive cost even further on an annual basis. Phoenix Pacific, Inc. is the original fire alarm vendor which furnished and commissioned the fire alarm system at Kauikeaouli Hale.</p>

In the designing and installation of fire alarm system all equipment were Phoenix Pacific proprietary authorized equipment.</p>
