Requesting a Family Court Protective Order Tingoren echo Family Court Protective Order

You may request a Family Court temporary restraining order (TRO) if the person engaging in domestic abuse is a family or household member.

En mei pwan tongeni tingor echo TRO non ewe Family Court ika ewe chon afeingaw ii emon aramasomw ika chochon ne imomw.

Domestic abuse is defined, as follows:

Ikkei ekkoch wewen **Domestic abuse**:

- Physical harm, bodily injury, assault, or the threat of imminent physical harm, bodily injury, or assault, extreme psychological abuse or malicious property damage; or Kapasen an mochen afeingawa emon ika a fen afeingawa emon, feingawen inis seni pen kawet, kapasen afeingawa mei afisata nuokusun non an emon ekkiek ika katangawen pisek; ika
- Any act that would constitute abuse of a family or household member, a sex offense, or a child abuse offense committed by an adult family or household member against a minor family of household member pursuant to Hawai'i Revised Statutes section 709-906, or under part V or VI of chapter 707.
 - Sokosokun foforun emon mei muuk an epwe neuni amanauwen kawet ika achimwan nisou ngeni emon semirit, chochon non famini ika chochon non ewe iimw, mei annuk fan nurun ewe allukun Hawai`i nampa 709-906, ika fan nurun ewe chapter 707, sopwun V ika VI.

Family or household members means, as follows:

Wewen chochon famini ika chochon non iimw, ikkei mei afatetiw:

- Current or former spouse or reciprocal beneficiary;
 Punuwomw ika punuwomw akoumw ika chon angei feiochumw;
- Persons who have a child in common;
 Rumon aramas mei wor nounour fengen
- Parents;

Sam me lin;

Children:

Nauw;

- Blood-related family members;
 Omw famini (futukomw/choomw):
- Persons currently or formerly in a dating relationship; or Ruwemon kamwet ika ruwemon kamwet akoumw; ika

 Persons currently or formerly residing together (but "residing together" does <u>not</u> include those persons who are, or were, adult roommates or cohabitants only because of an economic or contractual affiliation).

Ruwemon iir mei nom fengen ika tapin nom fengen (nge ewe foos "nom fengen" ese weneiti ekkewe iir mei achoiimw fan pechekunen ewe taropwen etipeew ren ar nom fengen fanasengesin aar repwe aninis fengen).

After the TRO Court Officer receives information about your domestic abuse allegations, and information regarding the person against whom you are filing, you will be scheduled for an appointment. During this appointment, your petition will be submitted to a judge for review, and the judge will decide whether to grant you a TRO.

The **application process** may take up to 2 hours for you to complete your petition. Please arrange for child care, if necessary.

Ewe fansoun amasowen taropwen tingor mei tongeni epwe tori 2 awa omw kopwe awesi. Tingor kopwe kutt noumw chon tumun semerit, ika mei wor noumw.

If the TRO is granted by the judge, keep a copy of your TRO with you at all times and report any violations to the police department immediately by calling 911.

Parking

For people wishing to file in Honolulu, the location for filing is at the Circuit Court building on Punchbowl Street and Pohukaina Street. There is usually available parking at the Circuit Court parking garage (Pohukaina St. entrance). The court does not validate parking.

If submitting your documents at the Family Court in Kapolei, there is metered parking available. The meters only take quarters and have a two hour limit so you will need to feed the meter again if you stay longer. For neighbor island applicants, please check with your respective court.

Ika kopwe wano noumw kewe taropwe non ewe Family Court non Kapolei, ka tongeni park non ekkewe meter parking. Ekkewe meter raa chok tongeni angei senis rúúwe-me-nimwu.
