ADDENDUM NO. 1 REQUEST FOR PROPOSALS NO. J20253 Nursing Services for the Period November 1, 2019 – June 30, 2021

The Judiciary, State of Hawaii

The items listed hereunder are hereby made a part of Request for Proposals (RFP) No. J20253 for the above Nursing Services project, and shall govern the work taking precedence over previously issued specifications governing the items mentioned.

Questions submitted relating to RFP J20253, with Judiciary Responses:

- Q1: Are you able to provide the annual spend on nursing for the past fiscal year?
- A1: The annual spend for the past fiscal year is \$129,658.13.
- Q2: What is the total number of FTEs anticipated for the contract?
- A2: This contract is for on-call nurses therefore, the working hours vary depending if there is a need for on-call nurses.
- Q3: What is the total number of hours spent on the contract in the past fiscal year?
- A3: The total number of hours for the past fiscal year is 2016.50 hours
- Q4: What are the expected work hours and work schedule?
- A4: The hours vary depending if there is a need for on-call nurses to cover an 8 hour shift for one of our full-time nurses and/or to cover intermittent shifts. This could range from 4 to 8 hours.
- Q5: What is the anticipated spend?
- A5: The anticipated spend is \$100,000.00 per fiscal year for service rendered, including incurred costs and applicable taxes.
- Q6: How many residents/use our house in each unit?
- A6: We have a 24-hour shelter that holds a 12 bed facility and our secured detention center is a 66 bed facility.
- Q7: What would be the anticipated start date of the contract?
- A7: The contract is anticipated to start November 1, 2019.

- Q8: Who is the current incumbent?
- A8: The current incumbent is Nursefinders, LLC
- Q9: Is it anticipated that the current incumbent would respond to the solicitation as well?
- A9: We have no knowledge of this information.
