6. Explain in detail why it is not practicable or not advantageous for the	Program/Division to procure by competitive means:			
For FY20-23, the Judiciary initially posted RFP J19100, SVC Spec 2.23, for mediation and related dispute resolution services, and MCH was the sole applicant. The Judiciary canceled the solicitation for SVC Spec 2.23 pursuant to Hawaii Admin. Rules § 3-143-613.				

MCH was the sole applicant. The Judiciary canceled the solicitation for SVC Spec 2.23 pursuant to Hawaii Admin. Rules § 3-143-613. Instead, the Judiciary signed a one-year exempt contract (J20015) to ensure continuity of the same services at then current levels, while the Judiciary implemented an online dispute resolution (ODR) pilot project for small claims cases in the First Circuit in FY20. Concurrently, in FY20, the Judiciary initiated a comprehensive online court system (OCS) project including e-filing and e-payment. OCS will significantly increase remote access to the courts and is a giant step in enhancing access to justice. The ODR pilot project, OCS, and the newly expanded civil JIMS and JEFS systems are now being integrated into a comprehensive system. The continued development of these programs requires more time, flexibility and adaptability in the contracting. A one-year exempt contract is

A one-year exempt contract is necessary to maintain existing mediation and related dispute resolution services during this transition, and it would not be practicable for a different provider to attempt to get up to speed in delivering mediation and related dispute resolution services at current levels.

7. Describe the reason for the selection of the provider including a description of how the procedure, as much as practicable, ensured maximum fair and open competition:

MCH's current contract for mediation and related dispute resolution services (J20015) ends on June 30, 2020, and the Judiciary needs the same services for a one-year period. MCH is well positioned to ensure the continuity of the same services. MCH is a well-established organization of community mediation centers and programs located on Oahu, Maui, the Island of Hawaii, and Kauai. MCH has a track record of successful performance under prior mediation and related dispute resolution services contracts since 1991. MCH continues to work closely with the courts and CADR. MCH is familiar with the various courts, court procedures, and the Judiciary contract and billing processes. Continuing with MCH minimizes training a new contractor with the court system, the contract/billing processes, and CADR program expectations.
