**ORDER CONTINUING TEMPORARY HOSPITALIZATION FOR A PERIOD NOT TO EXCEED NINETY (90) DAYS AND SETTING FURTHER HEARING
(CONDITIONAL RELEASE)**

By order filed on _____, this Court ordered the temporary hospitalization (not to exceed 72 hours) of the above-named Defendant. A review

hearing was held on _____ before the Honorable _____, Judge of the above-entitled court. The State of Hawaii was represented by Deputy Prosecuting Attorney _____. Defendant was present via video conferencing and was represented by Deputy Public Defender _____. _____ Department of Health, Forensic Coordinator, was present. Also appearing via videoconferencing were Defendant's social worker, _____, and Dr. _____, Defendant's treating psychiatrist.

The Court, having reviewed the pleadings and files herein and the report of Dr. _____, dated _____, and having heard the observations and opinions of Defendant's treatment team, and having considered the arguments of counsel, the Court finds that the Defendant will benefit from further hospitalization which may render revocation of Defendant's conditional release unnecessary.

IT IS HEREBY ORDERED that Defendant's hospitalization be extended for a period not to exceed ninety (90) days for further evaluation and treatment. A review hearing shall be held on _____, _____, 2_____, at _____ .m., in Courtroom _____, Kauai Judiciary Complex, 3970 Kaana Street, Lihue, Kauai, Hawaii. Defendant's treating psychiatrist shall prepare an updated report and shall transmit said written update to the Court on or before _____, 20_____.

Representatives of the Sheriff's Division or Public Safety designate shall effectuate the transport of Defendant to and from the Hawaii State Hospital to this court for the review hearing and for any further hearings as ordered by this Court. In the event that Defendant's treating physician determines that transport to the hearing set on _____ would present a risk of danger to Defendant or to others, or if the Defendant chooses to waive his/her physical presence at the hearing, Defendant's presence at the hearing may be by way of Video-Conferencing or waived.
