**ORDER COMMITTING DEFENDANT TO THE CUSTODY OF THE

1. That the Defendant shall be committed to the custody and care of the Director of Health until the next court hearing date of \_\_\_\_\_, at \_\_\_\_\_ .\_\_m.
2. That upon confirmation of bed space availability at the facility designated by the Director of Health, the Defendant shall be released from the Kauai Community Correctional Center.
3. That the examination of the Defendant pursuant to HRS Section 704-404 shall be conducted at the facility designated by the Director of Health.
4. That the Defendant's commitment to the facility designated by the Director of Health shall not exceed thirty (30) days, unless this Court determines that a longer period is necessary for the examination of the Defendant pursuant to HRS Section 704-404.

Counsel for the parties have stipulated that a period in excess of thirty (30) days is necessary and the Court so orders.
