YOU ARE HEREBY COMMANDED to take physical custody of Defendant above-named, forthwith, pursuant to Section 704-413, Hawai'i Revised Statutes, as amended, and have him/her brought before this Court in Lihue, Hawai'i, located at the Kauai Judiciary Complex, 3970 Kaana Street, Lihue, Hawaii.

YOU ARE FURTHER COMMANDED, upon securing the physical custody of the Defendant, to notify this Court or its Clerk by telephone or in person as to the custody status of Defendant so that the Court may schedule an immediate hearing concerning the revocation of Defendant's Conditional Release.
