YOU ARE HEREBY COMMANDED to take physical custody of the above-named Defendant, forthwith, pursuant to Section 704-406, Hawai`i Revised Statutes, as amended, and have the Defendant brought before this Court in Lihue, Hawai`i, located at the Kauai Judiciary Complex, 3970 Kaana Street, Lihue, Hawaii.

YOU ARE FURTHER COMMANDED, upon securing the physical custody of the Defendant, to notify this Court or its Clerk by telephone or in person so that the Court may schedule an immediate hearing concerning the revocation of Defendant's Release on Conditions and/or Order for Temporary Hospitalization.

YOU ARE FURTHER COMMANDED to segregate Defendant from the general prison or jail population and, to the extent practical, provide Defendant with appropriate mental health evaluations while Defendant is being held in custody by the Department of Corrections and Rehabilitation, any county police department, or any law enforcement agency during the period of time prior to Defendant's transfer to the custody of the Director of Health of the State of Hawai'i, as required by Clark, et al. YOU ARE FURTHER COMMANDED not to hold Defendant in a facility controlled by the Hawai'i Department of Corrections and Rehabilitation ("DCR Facility") for a period of time longer than the time needed to identify the person, determine his/her legal status, and determine whether the person will be charged with a crime, and in no case for a period that exceeds forty-eight (48) hours, except that transfer of custody from facilities on islands other than Oahu may exceed the forty-eight (48) hour period, so long as transport is made by the first available flight."
