Requesting a Family Court Protective Order Kajitok kin Protective Order jen Family Court (Ortar ñan Kojbarok)

You may request a Family Court temporary restraining order (TRO) if the person engaging in domestic abuse is a family or household member.

Komaroñ kajitok iben Famly Court kin temporary restraining order (TRO) (ortar ñan kojbarok) elañe armij eo ej koman jorren ko ilo mweo ej mottan baamle eo ak jokwe ilo mweo.

Domestic abuse is defined, as follows:

Melelein Domestic abuse (Jorren ko ilo mweo) ej laajrak einwōt in:

- Physical harm, bodily injury, assault, or the threat of imminent physical harm, bodily injury, or assault, extreme psychological abuse or malicious property damage; or
 Aoleb jorren ko rejelet enbinūm, manman, ak kamijaak ñan kejorren mour eo am, kakure enbinūm, kakure kelmenlokjen ak kakure men ko mweiem ilo wewin kommator; ak
- Any act that would constitute abuse or a family or household member, a sex offense, or a child abuse
 offense committed by an adult family or household member against a minor family of
 householmember pursuaant to Hawai'i Revised Statutes section 709-906, or under part V or VI of chapter
 707.

Jabrewōt wawin ko renaj watōke menin kakure baamle ak ro uaan mweo, kamakoko ñan babu iben, ak ritto ro rej kakure ajri ro ilo baamle eo ak ritto ro imweo rej komman joreen nae ajri ro mweo einwōt an walok ilo Hawai`i Revised Statutes section eo 709-906, ak iumin mōttan V ak VI ilo jepta 707.

Family or household members means, as follows: Baamle ak ro uaan mweo ej laajrak einwōt in:

- Current or former spouse or reciprocal beneficiary;
 Eo mottam ak kar ruturum ak wewin eo ruo armij rejjab maron belele ekkar nan kakien ako rej komman kon in mour ibben dron.
- Persons who have a child in common;
 Armij ro eor nejier iben dron;
- Parents:
 - Jinen/Jemen;
- Children;
 - Ajri ro;
- Blood-related family members;
 - Ro rej botoktokin im uaan baamle eo;
- Persons currently or formerly in a dating relationship; or Armij ro rej lo dron ak rekar lo dron; ak
- Persons currently or formerly residing together (but "residing together" does <u>not</u> include those persons who are, or were, adult roommates or cohabitants only because of an economic or contractual affiliation).
 Armij ro rej jokwe ak rar jokwe ibben dron (bōtab "jokwe iben dron" <u>ejab koba</u> armij ro rej jokwe iben dron kinke bolen rekar jiban dron ilo bill ak kon ko jet.)

After the TRO Court Officer receives information about your domestic abuse allegations, and information regarding the person against whom you are filing, you will be scheduled for an appointment. During this appointment, your petition will be submitted to a judge for review, and the judge will decide whether to grant you a TRO. The **application process** may take up to 2 hours for you to complete your petition. Please arrange for child care, if necessary.

If the TRO is granted by the judge, keep a copy of your TRO with you at all times and report any violations to the police department immediately by calling 911.

Parking Jikin Park

For people wishing to file in Honolulu, the location for filing is at the Circuit Court building on Punchbowl Street and Pohukaina Street. There is usually available parking at the Circuit Court parking garage (Pohukaina St. entrance). The court does not validate parking.

If submitting your documents at the Family Court in Kapolei, there is metered parking available. The meters only take quarters and have a two hour limit so you will need to feed the meter again if you stay longer. For neighbor island applicants, please check with your respective court.
