This matter comes before the Court in light of the public health emergency in the State of Hawai`i.

To further protect the health and safety of First Circuit District Court employees and all court participants, and pursuant to the Orders of Chief Justice Mark E. Recktenwald filed in SCMF No. 20-0000152, In re the Judiciary's Response to the COVID-19 Outbreak; the Orders of Chief Judge R. Mark Browning filed in SP No. 1CSP-20-0000082, In re the Circuit Court of the First Circuit's Response to the COVID-19 Outbreak; and with authority as Deputy Chief Judge of the District Court of the First Circuit, State of Hawai'i, the Court hereby orders as follows:

A. General court services at the Honolulu District Court

The Information Booth, located on the plaza of Kauikeaouli Hale
 (Honolulu District Court), shall be closed for renovations beginning on December 2, 2020, until further notice.

2. Beginning December 3, 2020, the Legal Documents counter on the third floor of the Honolulu District Court shall be open to the public, Monday through Friday, from 7:45 a.m. to 4:00 p.m. Individuals needing assistance are encouraged to visit the Legal Documents counter during the hours of 10:00 a.m. to 12:00 p.m. and 2:00 p.m. to 4:00 p.m., as wait times tend to be shorter during these periods.

B. <u>Non-custody criminal arraignments to be temporarily relocated from the</u> Honolulu District Court to the Kāne'ohe District Court

3. Beginning on December 14, 2020, arraignments and pleas in non-custody criminal matters scheduled at the Honolulu District Court shall be remotely heard at Kāne'ohe District Court by Zoom. The Zoom meeting ID is:
