TWELFTH AMENDED EMERGENCY ORDER #5  
REGARDING DISTRICT COURT OF THE FIRST CIRCUIT

This matter comes before the Court in light of the public health emergency in the State of Hawai‘i.

To further protect the health and safety of First Circuit District Court employees and all court participants, and pursuant to the Orders of Chief Justice Mark E. Recktenwald filed as of December 23, 2020 in SCMF No. 20-0000152, In re the Judiciary’s Response to the COVID-19 Outbreak, and with authority as Chief Judge of the First Circuit, the Court hereby orders as follows:

**I. Honolulu District Court**

**A. *In-person criminal and criminal traffic proceedings at the Honolulu District Court***

1. The following cases shall proceed as scheduled:
  - a. Initial appearances and preliminary hearings in felony cases;
  - b. Arraignment and plea for defendants in HPD custody;
  - c. Motions for release filed by defendants in HPD custody or OCCC custody;
  - d. Motions to revoke conditional release, motions to revoke probation, and motions pertaining to bail;
  - e. Hearings on the mental health calendar under Hawai'i Revised Statutes (Haw. Rev. Stat.) Chapter 704 on (1) motions for temporary hospitalization; (2) motions to revoke conditional release; and (3) hearings deemed essential by the presiding Judge; and
  - f. Quarantine violator cases.

To the extent possible, video conferencing shall be used for cases involving defendants in the custody of the Honolulu Police Department, the Oahu Community Correctional Center, and/or the Hawai'i State Hospital, as well as quarantine violator cases.

**B. Criminal proceedings at the Honolulu District Court**

2. Arrestment and plea.

a. *Remote arrestments and pleas for non-custody cases.* Other than cases referenced in paragraph 1, arrestments and pleas in non-custody criminal matters at the Honolulu District Court shall be remotely heard at Kāneʻohe District Court by Zoom.

If a defendant is unable to appear via Zoom, the defendant's case shall be continued to a date on or after March 1, 2021.

b. *In-person arrestments and pleas for non-custody cases.* A defendant may file a motion for in-person arrestment and plea. If the motion is granted, the arrestment and plea will be conducted on the date, time, and courtroom specified in the order.

3. Pretrial conferences.

a. *Remote pretrial conferences.* Except as provided in paragraph 4, all other criminal matters (*e.g.*, pretrial conferences, sentencing, status hearings, compliance hearings, and other non-evidentiary matters on the 7B calendar) at the Honolulu District Court shall be conducted remotely by Zoom. If a defendant is unable to appear via Zoom, the defendant's case shall be continued to a date on or after March 1, 2021.

b. *In-person pretrial conferences.* A defendant may file a motion for an in-person pretrial conference. If the motion is granted, the pretrial conference will be conducted on the date, time, and courtroom specified in the order.

4. Criminal trials postponed. All **criminal bench trials** (i.e., trials on the 7B and 7C calendars) at the Honolulu District Court shall be postponed to a date on or after March 15, 2021. Criminal cases with trial dates or trial weeks on or before March 12, 2021 will be converted to remote pretrial conferences and shall be conducted by Zoom. If a defendant is unable to appear via Zoom, the pretrial conference shall be continued to a date on or after March 15, 2021.

C. Criminal traffic proceedings at the Honolulu District Court

5. Arraignment and plea.

a. *Remote arraignments and pleas for non-custody cases.*

Arraignments and pleas in criminal traffic matters at the Honolulu District Court shall be remotely heard at Ali‘iōlani Hale (Hawai‘i State Supreme Court) by Zoom.

If a defendant is unable to appear via Zoom, the defendant’s case shall be continued to a date on or after March 15, 2021.

b. *In-person arraignments and pleas for non-custody cases.* A

defendant may file a motion for in-person arraignment and plea. If the motion is granted, the arraignment and plea will be conducted on the date, time, and courtroom specified in the order.

6. Pretrial conferences.

a. *Remote pretrial conferences.* Except as provided in paragraph 7,

**criminal traffic** matters scheduled on the 7A, 10C, and 10D calendars (e.g., pretrial conferences, sentencing, status hearings, compliance hearings, and other non-evidentiary matters) at the

Honolulu District Court shall be conducted remotely by Zoom. If a defendant is unable to appear via Zoom, the defendant's case shall be continued to a date on or after March 15, 2021.

b. *In-person pretrial conferences and other hearings.* A defendant may file a motion for an in-person pretrial conference or other hearing. If the motion is granted, the pretrial conference or other hearing will be conducted on the date, time, and courtroom specified in the order.

7. *DUI and other criminal traffic trials.*

a. Courtrooms 10C and 10D: All *criminal traffic bench trials* on the 10C and 10D calendars at the Honolulu District Court shall proceed as scheduled.

b. Courtroom 7A: All *criminal traffic bench trials* on the 7A calendar at the Honolulu District Court shall be postponed to a date on or after March 15, 2021. Cases with trial dates or trial weeks on or before March 12, 2021 will be converted to remote pretrial conferences and shall be conducted by Zoom.

D. *Specialty Courts*

8. *Remote DWI Court hearings to proceed.* DWI Court shall be conducted remotely by Zoom, unless otherwise ordered by the presiding judge.

9. *Remote Community Outreach Court hearings to proceed.* Community Outreach Court shall be conducted remotely by Zoom, unless otherwise ordered by the presiding judge.

E. *Traffic infraction proceedings at the Honolulu District Court*

10. *Remote traffic infraction hearings to proceed.* All traffic infraction hearings under Haw. Rev. Stat. § 291D-8 shall be conducted remotely by Zoom. If a defendant

is unable to appear via Zoom, the defendant may file a motion for an in-person hearing. Failure to appear or timely request an in-person hearing may result in a default judgment.

11. *Trials postponed.* All traffic infraction trials under Haw. Rev. Stat. § 291D-13 (trial de novo) shall be postponed to a date on or after March 1, 2021.

**F. *Civil proceedings at the Honolulu District Court***

12. *In-person hearings in civil cases to be conducted.* The following cases shall proceed as scheduled:

- a. Cases involving temporary restraining orders (TROs) and injunctions under Haw. Rev. Stat. § 604-10.5; and
- b. Cases involving TROs and injunctions based on illegal lockouts and utility shutoffs.
- c. At the discretion of the presiding judge, in-person hearings may be scheduled for summary possession and ejectment cases involving alleged physical harm, threats of physical harm, and/or safety and health violations.

13. *Remote hearings on the civil answer, motions, and returnable calendars to proceed.* Cases on the civil answer, motions, and returnable calendars shall be conducted remotely by Zoom, to the extent possible. Parties are encouraged to appear via Zoom. If a party is unable to appear via Zoom, the party may appear in person. Failure to appear may result in default or dismissal.

14. *Remote hearings on the civil pretrial conference calendar to proceed.* Cases on the civil pretrial conference calendar shall be conducted remotely by Zoom, to the

extent possible. Parties are encouraged to appear via Zoom. If a party is unable to appear via Zoom, the party may appear in person. Failure to appear may result in default or dismissal.

15. Civil trials. Civil trials and other civil matters at the Honolulu District Court shall proceed as scheduled, except as precluded by the eviction moratorium set forth in Governor David Y. Ige's Seventeenth Proclamation Related to the COVID-19 Emergency dated December 16, 2020 and/or any extension thereof.

**G. General court services at the Honolulu District Court**

16. The current hours of operation at the Legal Documents Branch on the third floor of the Honolulu District Court are Monday through Friday, 7:45 a.m. to 4:00 p.m. The Deputy Chief Judge of the District Court, First Circuit, may make further modifications to the dates and times during which such services will be available.

17. The current hours of operation for public services at the Traffic Violations Bureau are Monday through Friday, 8:00 a.m. to 12:00 p.m. The Deputy Chief Judge of the District Court, First Circuit, may make further modifications to the dates and times during which such services will be available.

18. Self-represented litigants (*i.e.*, parties without attorneys) in civil, criminal, criminal traffic, and temporary restraining order (TRO) cases shall submit documents electronically through the Court Document Drop-Off. Information about the Court Document Drop-Off service is available at:

In the event a party is unable to electronically submit a document through the Court Document Drop-Off service, the document may be filed in person.

19. Attorneys and self-represented litigants shall submit motions in traffic infraction cases electronically through the Court Document Drop-Off service. In the event an attorney or self-represented litigant is unable to electronically submit a document through the Court Document Drop-Off service, the document may be filed in person.

**II. 'Ewa District Court, Kāne'ohē District Court, Wahiawā District Court, and Wai'anae District Court**

**A. Criminal and criminal traffic proceedings at the 'Ewa District Court, the Kāne'ohē District Court, the Wahiawā District Court, and the Wai'anae District Court**

20. Arraignment and plea.

a. *Remote arraignments and pleas to proceed.* Arraignments and pleas in criminal and criminal traffic matters at the 'Ewa District Court, the Kāne'ohē District Court, the Wahiawā District Court, and the Wai'anae District Court shall be conducted remotely by Zoom. If a defendant is unable to appear via Zoom, the defendant's case shall be continued to a date on or after March 1, 2021.

b. *In-person arraignments and pleas.* A defendant may file a motion for in-person arraignment and plea. If the motion is granted, the arraignment and plea will be conducted on the date, time, and courtroom specified in the order.

21. Pretrial conferences.

a. *Remote criminal and criminal traffic pretrial conferences to proceed.* Except as provided in paragraph 20, all other criminal and criminal traffic matters (e.g., pretrial conferences, sentencing, status hearings, compliance hearings, and other non-evidentiary matters) at the 'Ewa District Court, the Kāne'ohē District Court, the Wahiawā District Court, and



the Wai‘anae District Court shall be conducted remotely by Zoom. If a defendant is unable to appear via Zoom, the defendant’s case shall be continued to a date on or after March 1, 2021.

b. *In-person criminal and criminal traffic pretrial conferences.* A defendant may file a motion for an in-person pretrial conference. If the motion is granted, the pretrial conference will be conducted on the date, time, and courtroom specified in the order.

22. *Trials to proceed.* Criminal and criminal traffic bench trials at the ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court shall proceed as scheduled.

**B. *Traffic infraction proceedings at the ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court***

23. *Remote traffic infraction hearings to proceed.* All traffic infraction hearings under Haw. Rev. Stat. § 291D-8 shall be conducted remotely by Zoom. If a defendant is unable to appear via Zoom, the defendant may file a motion for an in-person hearing. Failure to appear or timely request an in-person hearing may result in a default judgment.

24. *Trials may resume.* Traffic infraction trials under Haw. Rev. Stat. § 291D-13 (trial de novo) may resume to the extent court operations permit.

**C. *Civil proceedings at the ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court***

25. *Remote hearings to be held in most civil cases.* Other than regular claims trials, civil cases at the ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court shall be conducted remotely by Zoom, to the extent possible. Parties are encouraged to appear via Zoom. If a party is unable to appear via Zoom, the party may appear in person. Failure to appear may result in default or dismissal.

26. Regular claims trials. Regular claims trials at the ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court may proceed as scheduled, except as precluded by the eviction moratorium set forth in Governor David Y. Ige’s Seventeenth Proclamation Related to the COVID-19 Emergency dated December 16, 2020 and/or any extension thereof.

**D. General court services at the ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court**

27. The ‘Ewa District Court, the Kāne‘ohe District Court, the Wahiawā District Court, and the Wai‘anae District Court shall remain open to the public for general court services. The current hours of operation for public services are:

‘Ewa District Court:	8:00 a.m. to 12:00 p.m.
Kāne‘ohe District Court:	8:00 a.m. to 12:00 p.m.
Wahiawā District Court:	8:00 a.m. to 12:00 p.m.
Wai‘anae District Court:	8:00 a.m. to 12:00 p.m.

The Deputy Chief Judge of the District Court, First Circuit, may make further modifications to the dates and times during which such services will be available.

28. Self-represented litigants (*i.e.*, parties without attorneys) in criminal and criminal traffic cases shall submit documents electronically through the Court Document Drop-Off. Information about the Court Document Drop-Off service is available at:

In the event a party is unable to electronically submit a document through the Court Document Drop-Off service, the document may be filed in person at the respective courthouse during the hours referenced in paragraph 27.

29. Attorneys and self-represented litigants shall submit motions in traffic infraction cases electronically through the Court Document Drop-Off service. In the event an attorney or self-represented litigant is unable to electronically submit a document through the Court Document Drop-Off service, the document may be filed in person at the respective courthouse during the hours referenced in paragraph 27.

Remote court hearings are open to the public. Parties, attorneys, and members of the public are advised to dress and behave appropriately.

31. No person shall enter any Judiciary facility in the First Circuit if that person has: (i) a fever, cough, shortness of breath or difficulty breathing, or other symptoms of respiratory illness or of COVID-19 as set forth by the Centers for Disease Control and Prevention (“CDC”); (ii) had close prolonged contact with a person who has or is suspected to

have COVID-19; or (iii) traveled outside of Hawai'i in the past ten (10) days and have not satisfied the negative test exception to the mandatory self-quarantine period, subject to any subsequent out-of-state travel restrictions imposed through Statewide or County emergency orders, rules, or proclamations.

Furthermore, any person entering any Judiciary facility shall wear an appropriate face covering as described and recommended by the CDC (both inside and outside the courtroom), unless exempt, and shall maintain appropriate social distancing of at least six feet while visiting Judiciary facilities (both inside and outside the courtroom).

32. The Deputy Chief Judge of the District Court, First Circuit, may issue additional orders and adjust court operations consistent with this Order and the Orders of Chief Justice Mark E. Recktenwald filed in SCMF No. 20-0000152, *In re the Judiciary's Response to the COVID-19 Outbreak*.

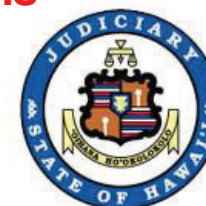
