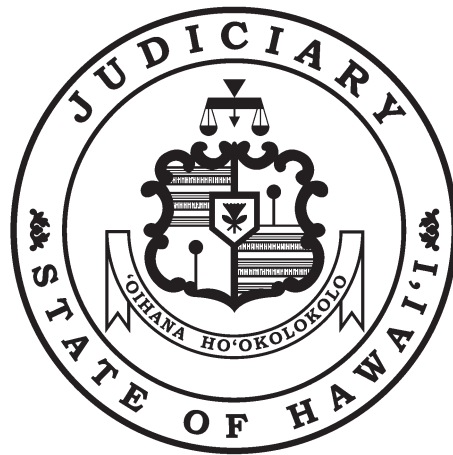

Primary Cases are original cases filed in the Office of the Chief Clerk of the Supreme Court. Appeals and original proceedings are classified as primary cases.

Supplemental Proceedings arise out of primary cases. During the fiscal year, of the 2,376 supplemental proceedings filed, 419 were filed in the Supreme Court and 1,957 were filed in the Intermediate Court of Appeals.
