Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means: Originally installed at Ali'iolani Hale in January 2005 and expanded to include the Kapuaiwa Building in February 2006, the System's original warranty from the manufacturer for parts and labor expired in 2008. To maintain the System, approval was obtained in 2009 to purchase a two-year service agreement. Every year since then, a new contract has been procured to provide uninterrupted service with the last agreement expiring on December 31, 2021. In order to continually support and maintain the System in peak working condition, another one-year service agreement is highly recommended. SRP replaced the original installer of the System (Sensormatic Hawaii) and has worked on the System since its expansion in 2006. As such, SRP has the knowledge and technical expertise necessary to maintain the System and has consistently performed well during service and repair work in the past. In addition, SRP is the only company in Hawaii authorized, certified and trained to service and maintain the software of the System.
