This matter comes before the Court in light of the public health emergency in the State of Hawai`i.

Pursuant to the orders issued by Chief Justice Mark E.

Recktenwald filed January 27, 2022, August 6, 2021, and March 16, 2020 in

SCMF-20-0000152 and with the authority as Deputy Chief Judge of the aboveentitled Court, IT IS HEREBY ORDERED:

 In person travel to Molokai and Lana`i for District Court proceedings, will be temporarily suspended, however, District Court matters on Molokai and Lana'i will continue to be calendared and heard via Zoom.

- 2. Any judge presiding in a criminal case may, however, order trial to proceed if: 1) the defendant will not consent to a continuance; 2) failure of the trial to proceed may result in dismissal for violation of Rule 48 or defendant's speedy trial rights; 3) sufficient court personnel are available for trial to proceed; 4) and that it may do so safely. A presiding judge ordering a criminal case to proceed to trial should promptly notify appropriate judiciary personnel so that travel arrangements can be made.

 Zoom Meetings. Please contact District Court one (1) week in
 advance to make any necessary arrangements for evidentiary

Witnesses called to testify in any criminal matter by the State of Hawai'i are not excused from an in court appearance.
