6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

Johnson Controls is the Judiciary's present maintenance contractor for Keahuolū's ventilation and air conditioning system. It is advantageous to have one party responsible for the proper functioning of the ventilation and air conditioning systems. Allowing another vendor to work on this exhaust fan exposes the Judiciary to potential multi-vendor conflicts which may impair the functioning and maintenance of the ventilation and air conditioning systems.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

We selected the Johnson Controls, Inc. because they are the Judiciary's present maintenance contractor for Keahuolū's ventilation and air conditioning system. Their services were procured by exemption for a term of one year, 09/14/2021 to 09/13/2022.
