To maintain consistency in the Judiciary's security, it would be in the best interest to retain Security Resources Pacific, Inc., to install both the access control and video surveillance systems at Lahaina District Court. Having one vendor, Security Resources Pacific, Inc., will also allow Lahaina District Court security cameras to be monitored by sheriffs located at Hoapili Hale. Therefore, increasing security at Lahaina District Court since their cameras are only monitored when a sheriff is available. It would additionally allow staff access to both buildings utilizing the same ID badge.					
Judiciary will also benefit from cost savings since the vendor has set standardized pricing for additions/expansions to the system. Therefore, we are requesting an exemption from HRS chapter 103D for these additions to expand the existing systems to Lahaina District Court.
