6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

CML is Judiciary's current maintenance vendor for the Kona courthouse security systems. Replacement UPS's will be integrated into the existing security system. Reliability and consistency are critical for security systems. Therefore, it is not practicable or not advantageous to procure by competitive means to avoid the uncertainties and complications of involving multiple vendors for the security system.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

CML is the Judiciary's current vendor and is performing satisfactorily as the maintenance and support contractor for Kona courthouse security systems. DAGS competitively procured and awarded a contract for the Kona courthouse security system. However, the vendor abandoned the job and therefore, DAGS engaged CML to continue services. Selecting another vendor to work with the system may create uncertainties and complications within the system.
