6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

Under Kauikeaouli Hale AC upgrade 12-21-7528 in 2015 Carrier had been contracted by Judiciary to bring the present DOC up from sub-standard to the present. Carrier Air Conditioning is sole contractor to inspect and troubleshoot all internal parts and replace with only Carrier parts that no other air conditioning company has rights to.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

Carrier Air Conditioning under Kauikeaouli Hale AC upgrade 12-21-7528 installed starter controller for Carrier chiller 3 which in turn had to be tie in with DOC programming. Carrier Air Conditioning perform their integrating into their Carrier DOC system. To go ahead to solicit another vendor to upgrade DOC system would not be practical as Carrier Air Conditioning is the only vendor that had sole interest in the initial programming to their Carrier chiller 3 starter controller and DOC system integratration.
