Allowing another vendor to work on our system exposes the Judiciary to potential multi-vendor conflicts which may impair the functioning and maintenance of the ventilation and air conditioning systems.</p>

Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:</p> <p>We selected the Johnson Controls, Inc. because they are the Judiciary's present maintenance contractor for Keahuolū's ventilation and air conditioning system.
