 Johnson Controls is the Judiciary's present maintenance contractor for Keahuolu's ventilation and air conditioning system. It is advantageous to have one party responsible for the proper functioning of the ventilation and air conditioning systems. Allowing another vendor to work on our system exposes the Judiciary to potential multi-vendor conflicts which may impair the functioning and maintenance of the ventilation and air conditioning systems.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:
 We selected the Johnson Controls, Inc. because they are the Judiciary's present maintenance contractor for Keahuolu's ventilation and air conditioning system. Their services were procured by exemption for a term of one year, 09/14/2022 to 09/13/2023.
