6. Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means:

Oahu Air is the Judiciary's present maintenance contractor for Hale Kaulike's ventilation and air conditioning system. It is advantageous to have one party responsible for the proper functioning of the ventilation and air conditioning systems. Allowing another vendor to work on our system exposes the Judiciary to potential multi-vendor conflicts which may impair the functioning and maintenance of the ventilation and air conditioning systems.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

We selected the Oahu Air because they are the Judiciary's present maintenance contractor for Hale Kaulike's ventilation and air conditioning system. Their services were procured by formal bidding. We are in the second of two extension options. The present extension is effective for the one year period, 07/01/2022 to 06/30/2023.
