**FORECLOSURE OPERATIONAL ORDER #2 REGARDING  
THE FORECLOSURE CALENDAR OF THE FIRST CIRCUIT**

In light of the last emergency proclamation related to COVID-19 having ended in March 2022 and pursuant to the Orders of Chief Justice Mark E. Recktenwald in SCMF No. 20-0000152, In re the Judiciary's Response to the COVID-19 Outbreak, and with my authority as Chief Judge of the First Circuit,

IT IS HEREBY ORDERED, **effective April 1, 2023**, that:

1. Foreclosure Operational Order #1 Regarding the Foreclosure Calendar of the First Circuit (filed March 21, 2022) is rescinded.

2. Face masks or coverings are recommended, but are no longer required, during open houses and public auctions.

3. No person shall participate in an auction or open house if they: (1) have tested positive for COVID-19 in the previous 5 days; (2) have COVID-19 symptoms; or (3) are subject to an isolation or quarantine request or order by any public health official or licensed medical physician.

4. All hearing motions in foreclosure cases scheduled before Judge Castagnetti shall be conducted in-person unless otherwise ordered.

5. When attending any hearing in-person, court participants must follow the restrictions and requirements of General Order #2 Regarding All Trial Court is of the First Circuit of the State of Hawai'i (filed December 19, 2022).
