It is not possible for the Program/Division to procure by competitive means these services as the current HVAC system needing to be upgraded is JCI's Intellectual property. Because of their unique technical nature, servicing of these controls must be performed by Johnson Controls to ensure optimal operating conditions for the system. Johnson Controls Honolulu is the sole supplier of these systems. Service performed by non-Johnson Controls providers may not have access to all software updates and required products.

Johnson Controls HVAC monitoring system was part of the original construction of the building and Johnson controls has maintained this proprietary system since the building went live.
