a. The unique features, characteristics, or capabilities of the goods, service or construction.

Hilo Judiciary Complex uses Automated Logic Web CTRL products for its environmental controls. Island Controls Inc. installed all the original equipment for Hilo Judiciary Complex and they solely represent the Automated Logic Web CTRL equipment and maintenance in the State of Hawaii. ALC's reputation is predicated upon providing building automation systems which are intuitively designed, feature rich, extremely powerful, and provide many years of reliable operation. Island Controls' local expertise and resources, combined with the company's access to Island Controls' engineering resources and support reassures that the Judiciary will continue to have access to their expertise and support.
