Pursuant to HRS § 103D -306 and HAR Chapter 3-122, Subchapter 9, The Judiciary requests sole source approval to purchase the following:

1. Describe the goods, services or construction to be procured:

To install the horizontal cabling for the Judiciary's Integrated Security Camera Surveillance and Recording System (System) at Ali`iolani Hale. This cabling will power up 26 interior cameras, 17 gunshot detection devices and 41 public address speakers, which will be placed at strategic locations throughout the building. The Judiciary shall front the costs of this project from its operating budget which will then be reimbursed back to the supreme court fiscal office by way of a federal grant. See Section 6 below.

6. Describe in detail the following:

a. The unique features, characteristics, or capabilities of the goods, service or construction.

In September 2016, the Judiciary was awarded a \$175,000 grant from the Homeland Security Grant Program (HSGP) through the State Department of Defense (DOD), to begin Phase 1 of the installation of the System. In September 2018, the Judiciary was awarded \$200,000 for Phase 2. Both phases were managed by the DAGS, and Security Resources Pacific (SRP) was awarded as the security contractor. In September 2020 and 2022, the Judiciary was awarded \$150,000 and \$160,000 from HSGP, respectively, which will cover the costs to install all the horizontal cabling at Ali'iolani Hale as mentioned above. Once Phase 3 is completed, the System will be integrated into the existing Proximity Access and Identification Card System (PAICS) at both buildings to maximize the security capabilities and potentials of each system. The importance of integrating is twofold: (1) If forced entry is detected, cameras located in that area will switch on automatically and start recording; (2) If motion is detected, the System will send an alert to the PAICS to automatically display preprogrammed building floor plans on a monitor showing the exact location of the incident. Corresponding camera(s) in the area turn on allowing law enforcement to view the situation and determine the appropriate response. The System will also be integrated into the Keyboard Alert System (KAS) which utilizes existing desktop keyboards as a duress alarm, to provide employees with a means to quickly and silently notify first responders up to 1,000 users, or more if so desired. The current capabilities mentioned above will also be bolstered by the addition of the Judiciary Gunshot Detection Program (JGDP). The JGDP consists of thirty-two (32) gunshot detection devices that are able to detect the sound of a gunshot. These devices would provide law enforcement with live footage of the System. In a Active Shooter Event, the devices would locate the sound of a gunshot and corresponding cameras would provide law enforcement with live footage of the shooter, while recording the

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department.

Originally installed at Ali'iolani Hale in January 2005 and expanded to the Kapuaiwa Building in February 2006, the PAICS allows users access by scanning their Judiciary issued ID badges with any access control reader programmed for authorized entry. SRP has been the only security contractor for the System since 2006. As such, SRP has the knowledge, technical expertise and engineering necessary to fully service, maintain and support all aspects of the System. For the past 17 years, SRP has consistently performed well during service, troubling shooting, repair or expansion work, and responding to these needs in a timely manner. SRP currently holds the maintenance contract for the System and has held this contract every year since 2007. The potential of this project will create critical infrastructure enhancements needed to allow the Judiciary the ability to provide the Department of Public Safety (DPS) the tools and technology necessary to improving and increasing courthouse security at Ali`iolani Hale, Supreme Court, and the Kapuaiwa Building, Intermediate Court of Appeals, where the core leadership of the third branch of government resides. The sharing of information will create and provide timely, detailed, and actionable intelligence. As a result, DPS and other first responders will be better able to provide a fast and accurate response maximizing public safety resources during emergency situations.
