Pursuant to HRS § 103D -102 (b)(4) and HAR Chapter 3-120, The Judiciary requests to amend an exempt contract as follows:

3. Describe the goods and/or services:

Outcome evaluation of the Driving While Impaired (DWI) Court Program to determine if the program is having the intended impact, including reducing recidivism and safer roads. NPC Research will identify participants who have entered the program since the court was implemented as well as a sample of individuals eligible for the DWI Court (based on demographics, arrest history, treatment history and any available assessment results) but who did not enter the DWI court and received traditional court processing. NPC Research will track data for both program and comparison groups through existing administrative databases for a period of up to 36 months post program entry to determine if there are differences in recidivism rates between the drug court and the comparison group.

4. Explain in detail what is being amended:

Contract term is being extended from 10/1/2023 - 9/30/2024; Year 2 funding of \$80,000.00

5. Amended contract price for this request:

Not to exceed \$80,000.

6. Explain in detail why the amendment(s) are necessary:

3-year period contract (1/1/2023 - 9/30/2025) is in place. However, funding is subject to Judiciary's receipt of federal funds through the State and Community Highway Safety formula grant program through the Department of Transportation. Grant for FFY 2024 (10/1/2023 - 9/30/2024) has been approved.
