This matter comes before the Court to address the wildfire that caused catastrophic damage in parts of Maui County including Lahaina. Adjustments to Judiciary operations as they relate to Lahaina District Court are necessary in order to ensure the health and safety of Court users and Judiciary personnel, and efficient and accessible administration of justice.

Pursuant to the Order of Chief Justice Mark E. Recktenwald filed August

11, 2023 under SCMF-11-0000088, and with the authority as Chief Judge of the above-

entitled Court,

IT IS HEREBY ORDERED, effective immediately:

1. Lahaina District Court will be convening in Wailuku District Court.

2. All Lahaina Division cases with court dates from Wednesday, August 9, 2023 to Thursday, August 17, 2023 have been rescheduled to future dates in Lahaina District Court, with the exception of Temporary Restraining Orders which continue to be heard in Wailuku District Court. Court dates may be subject to rescheduling.

Lahaina District Court for the week of August 21, 2023 will be reset to Wailuku District Court to the week of September 11, 2023 in accordance with the following schedule:

## Courtroom 3D:

Traffic/Criminal Defendants Last Names A through L which were set for Mondays will be heard on Tuesdays at 9:30 a.m.; cases set for Wednesdays will be heard on Thursdays at 9:30 a.m.

> Temporary Restraining Orders will be heard on Mondays at 9:30 a.m. Small Claims will be heard on Mondays at 2:00 p.m.

Courtroom 3C:

Traffic/Criminal Defendants Last Names M through Z which were set for Mondays will be heard on Tuesdays at 9:30 a.m.; cases set for Wednesdays will be heard on Thursdays at 9:30 a.m.

Regular Claims will be heard on Mondays at 10:30 a.m.

3. Unless otherwise ordered by the Court, subsequent weeks will be scheduled in accordance with the schedule set forth herein.

4. All Lahaina Division Traffic Default Judgments will be stayed for a period of SIXTY (60) DAYS.
